## INSTRUMENT OF GOVERNMENT VARIATION ORDER

## THE SCHOOL GOVERNANCE (CONSTITUTION) (ENGLAND) REGULATIONS 2012

Made: On 30<sup>th</sup> January 2025

Coming into force: On 11th December 2024

The Rochdale Borough Council being the Local Authority hereby make the following variation order:

'The Cardinal Langley Roman Catholic High School Instrument made by the Council on 20<sup>th</sup> March 2024 (number in seal book **47019**) shall be amended by virtue of the following changes to its constitution in accordance with the requirements of section 13 of the School Governance (Constitution) (England) Regulations 2012.

- 1. The name of the school is CARDINAL LANGLEY ROMAN CATHOLIC HIGH SCHOOL.
- 2. The school is a Voluntary Aided school.
- 3. The name of the Governing board is: THE GOVERNING BOARD OF CARDINAL LANGLEY ROMAN CATHOLIC HIGH SCHOOL.
- 4. The Governing board shall consist of i:
  - a. Two Parent Governors
  - b. One LA Governor
  - c. One Staff Governor
  - d. One Headteacher Governor
  - e. Eight Foundation Governors [must outnumber the other Governors by two]
  - f. One Co-opted Governor

## **Total number of Governors - Fourteen.**

- 5. Foundation Governors are appointed and may be removed by the Bishop of Salford (or any other person exercising jurisdiction on his behalf).
- 6. The school was founded by and is part of the Catholic Church. The school is to be conducted as a Catholic School in accordance with the canon law and teachings of the Roman Catholic Church, and in accordance with the Trust Deed of the Diocese of Salford and in particular:

- a) religious education is to be in accordance with the teachings, doctrines, discipline and general and particular norms of the Catholic Church;
- b) religious worship is to be in accordance with the rites, practices, discipline and liturgical norms of the Catholic Church;

and at all times the school is to serve as a witness to the Catholic faith in Our Lord Jesus Christ.

- 7. This instrument of Government comes into effect on 11th December 2024.
- 8. This instrument was made by order of Rochdale Local Authority on 30<sup>th</sup> January 2025.
- 9. A copy of the instrument must be supplied to every member of the Governing board (and the headteacher if not a governor), any trustees and to the appropriate religious board.
